<b><u>Course summary</u></b>	
<p>Course aims - to develop the students understanding of the regional system in which a whole world intertwine, the EU and Latvian regions; it particularly emphasizes Eastern area regional characteristics and their socio-economic development of the underlying trends. The course focuses on the theoretical aspects of the process of regionalization of the world globalization process in modern trends in perspective. Course main objectives - to deal with the territorial organization of the economy and methods of spatial planning frameworks; to examine the eastern areas of natural resources and investment potential research opportunities and economic evaluation method; look at the criteria that determine the socio-economic development and their competitiveness in the new economic paradigm.</p>

5. Regional economic development in Russia (resource potential, sector development, investment and innovation). (4 hrs.)
6. Main points of development and economic integration in Eastern European countries. (4 h).

Seminar topics:

1. Regional economic and administrative peculiarities of Poland (resources, industry development, investment and innovation). (2 hrs.)
2. Regional economic and administrative peculiarities of Russia (resources, sector development, investment and innovation). (2h).
