Study course abstract

This course provides introduction to the basic concepts in macroeconomics, with a focus on the Eastern Europe. This course develops a basic understanding of economy-wide issues such as growth, composition, and fluctuation of overall output, the determinants of unemployment, inflation, and the role of the financial system in facilitating savings and investment. Course aim is to provide students with theoretical and practical knowledge of different economic situation within the meaning of economic sectors interact, and depending on what is necessary to determine economic policy decision making and analysis. Course takes a comparative approach of different economic indicators in Eastern European economies. To link the basic principles of economic theory and to be able to assess the economic situation in the country, in the region, as well as to analyse trends, students solve various problem situations, participate in discussions. This course provides description of the internal resources and potential in the Eastern European countries.
